# PRIVACY STATEMENT

## WEBSITE DATA

The main data we collect comes from the membership form you complete. This data is entered onto our website by the Membership Secretary. You can access the website to amend this data as necessary.

Your contact information is never shown to the general public - public visitors to the website will only be able to see your name and any information you may have entered in the "details" field. You should not enter private information in this field.

Members logging onto the website can access other adult members' contact details. You can choose to hide your contact details if you wish.

Radlett Cricket Club provides access to a limited number of people either to carry out the tasks outlined below, or to administer the website. These people will have visibility of all the information held in the website database. They comprise members of the Radlett CC Executive Committee, website administrators, captains and team managers. Access rights are reviewed on a regular basis.

The information held is used to communicate with you as follows:

- To advise you of your selection to play for the Club
- To send emails inviting you to participate in events organised by the Club
- To send you a regular newsletter about the Club
- Potentially, to advise you of special offers available to you as a member of the Club
- To maintain statistics relating to the playing of cricket, including personal averages.

Any communication to you will come direct from Radlett CC and be generated from the website, ensuring the data is up-to-date. We will never pass your data over to a third-party, unless a) we are legally required to do so, or b) the information is required to enable you to play in a particular competition.

The website is provided by HitsSports Ltd, whose registered office is at 23 Church Street, Rickmansworth, WD3 1DE. They are the designers, owners and hosts of the website.

Email addresses and phone numbers may also be held by team managers or captains to enable them to communicate with players in their teams.

## GIFTAID AND EVENTS

GiftAid forms are held by the Club Secretary. This data is entered onto a spreadsheet to facilitate the GiftAid claims, submitted to HMRC through their portal. This necessitates also keeping spreadsheet records of attendees at events where donations are made. The Club Secretary is the only person authorised by HMRC to make these claims and, as such, is the only person holding this data.

## ACCOUNTING DATA

The Club's accounts are held in the Xero accounting system. This is a cloud-based system. Xero use "top tier", third-party data hosting providers (Rackspace, AWS, and Microsoft Azure) to host their services on servers located in the USA. They have in place transfer mechanisms with all their third-party data-hosting providers that satisfy the requirements of the European Union. Radlett CC's instance of Xero holds records of all accounting transactions. It will therefore contain a record of all those who have paid memberships, but this is limited to a payee's name.

## BAR ACCOUNT

Adult members may set up an account at the bar, which they top-up and which gives a discount on drinks and snacks. Only your name and payment history is held on the system.
